In *Huber v. State*, Supreme Court Case No. S-16190, *DeRemer v. State*, Supreme Court Case No. S-16194, and *Walker v. State*, Supreme Court Case No. S-16202, the superior court ruled that prisoners had waived certain issues by their failure to raise them in their appeal to the superintendent under 22 AAC 05.480. To resolve this issue, this court desires further briefing on the question of "issue exhaustion" as thoroughly discussed in the opinions reported in *Sims v. Apfel*, 530 U.S. 103 (2000).

IT IS THEREFORE ORDERED that the parties shall simultaneously file memoranda of up to twenty pages in length addressing the following questions:

- 1. Do the prisoner discipline statutes or regulations require a prisoner to raise an issue on appeal to the superintendent in order to preserve the issue for judicial review?
- 2. In light of the broad authority given to the superintendent under 22 AAC 05.480, is it appropriate to require the issue preservation typical of adversarial judicial proceedings?
- 3. Does a prisoner have notice that the failure to raise an issue on appeal to the superintendent will result in waiver of that issue?

The ACLU of Alaska and the Alaska Association of Criminal Defense Lawyers are invited to file amicus briefs.

The cases are not being consolidated at this time. However, each party may file a single brief.
