

**ORDER GRANTING MOTION FOR TEMPORARY RESTRAINING  
ORDER AND PRELIMINARY INJUNCTION**

Plaintiffs American Civil Liberties Union of Alaska, Dunleavy for Alaska, and Eric Siebels having moved pursuant to Alaska R. Civ. P. 65(a) and (b) for a temporary restraining order and preliminary injunction enjoining further enforcement of AS 19.25.075-.180 by the State of Alaska Department of Transportation & Public Facilities, and the Court having considered the pleadings, exhibits and arguments of the parties, and being fully advised, the motion is hereby GRANTED. The Court finds that Plaintiffs have demonstrated probable success on the merits of their claim that AS 19.25.075-.180 is unconstitutional on its face and as applied.

IT IS HEREBY ORDERED that the State of Alaska Department of Transportation & Public Facilities is temporarily restrained and preliminary enjoined from further enforcement of AS 19.25.075-.180 pending a full resolution of this case on the merits.
